2006 Hall of Fame Inductees



Harold "LeLe" Bartlett

Bartlett is a 1944 graduate of Russellville High School, who received a Bachelor of Science degree from Arkansas Tech University in 1950.

Bartlett also has three graduate hours from Arkansas Tech, three from Henderson State University and six from the University of Central Arkansas. In 1972 he received his Masters Degree in Vocational Education from

the University of Arkansas.

Bartlett worked in the Russellville Public Schools for 28 years. His previous job experience was as director of the Russellville Area Vo-Tech Center, which serves students in Pope, Johnson and Yell counties; marketing education teacher-coordinator; supervisor of adult education and with Texaco, Inc. of Pope, Yell and Conway counties.

Bartlett went into the Russellville High School Hall of Fame in 1944, denoting his scholastic and athletic excellence. He received an honorable discharge from the United States Air Force in 1948. He was named Outstanding Marketing Distributive Education Teacher in Arkansas in 1981.

Bartlett was a member of the Arkansas Officials Association for 44 years. Bartlett's official experience includes a high school All-Star football game in 1965 and the Class AAAA state football championship game in 1985. He served as a referee in the AIC for 35 years, and worked a national NAIA playoff game in 1983 and the national championship game in 1986. He was named to the Hall of Distinction at ATU in 2003 and received a Russellville Cyclone Volunteer Service Award (40 years of service) in 2004. In 1950 he served one term on the AOA

Executive Board.

Bartlett worked track and field from 1960 to 2000. He worked as a timer and finish line coordinator for four Meet of Champions, four high school state meets, two conference meets and two national NAIA championships.

Bartlett's professional memberships include the Russellville Education Association, Arkansas Education Association, National Education Association, Arkansas Vocational Education Association, American Vocational Education Association, Arkansas Association of Marketing Education Teachers, National Association of Marketing Education Teachers and the Distributive Education Clubs of America.

Bartlett was president of the Russellville Jaycees. He was named Outstanding Local President of Arkansas State Jaycees. He served as the Russellville Rotary Club president, vice-president, and as a Board Member. He is a member of the Russellville Chamber of Commerce and a charter member of the Chamber's prestigious Red Coat Committee. He's an ATU Endowment Fund Worker and ATU Foundation Board of Director.

Bartlett is a life-long member of Central Presbyterian Church, where he served as deacon, ruling Elder, Sunday School superintendent and trustee. He also served as one of the teachers of men's Bible Class.

Harold and his wife Marian have two sons, David and Kent and a daughter, Nancy. Both sons are members of the Russellville High School Hall of Fame. David is president of Simmons Bank in Hot Springs. Kent is a dentist practicing in Russellville. Nancy is a graduate of UAMS School of Dental Hygiene and lives in Little Rock.



Thomas "Sonny" Downs

Downs is one of the few Arkansas high school officials to officiate the finals and state tournaments in three sports – football, basketball and baseball.

Downs football career spanned 31 years and amassed some 800 games. He worked 31 playoff games and two state final games. He also worked the Texas State High School All-

Star football game in Amon Carter Stadium in Fort Worth, Tex. Downs also worked in the Arkansas Intercollegiate Conference for three years.

Downs officiated approximately 3,000 basketball games over 32 years. He worked numerous district tournaments, eight regional tournaments and two state tournaments. He also worked a state final game in Pine Bluff as well as the 1987 Arkansas Girls All-Star game in Little Rock.

Downs' baseball career covered 25 years and over 800 games. He worked four regional tournaments and three state tournaments.

Downs served District 7 of the Arkansas Officials Association as president and vice-president. He presented numerous clinics in the three sports he officiated.

His officiating career was curtailed in 2004 when he was felled by a sudden stroke five days before the 2004 football season was to begin.

Downs played basketball at Texarkana Community College and attended Henderson State Teachers College. He is retired from the United States Postal Service where he was Chief of the Regional Vehicle Maintenance Facility in Texarkana. Sonny also served his country in the Texas National Guard and retired after 41 years as a First Sergeant. He served on active duty in 1961-62 during the Berlin Crisis.

Downs coached Texarkana Boys Club baseball, basketball and football teams for many years. He is a member of the Rose Hill Baptist Church.

Downs and his wife Sandra have been married for 46 years and they have one daughter, Sarah and her husband Carl Shooter, and one granddaughter, Rebecca, age 13.

Mike New

New graduated from Conway High School in 1969 and received his BSE from the University of Central Arkansas in 1974.

New was commissioned as a 2nd Lieutenant in the United States Army in 1974. He received an honorable discharge in 1982 and served in the United States Army Reserve.

New returned to his high school alma mater (Conway) in 1975 as an assistant football, track and basketball coach. He worked in the Conway School District until 1979. He



Gary Slaughter

Slaughter is a Hughes Springs, Tex. native, but his roots are deep in Arkansas. He received his BBA in Management/ Marketing from Texas A&M-Commerce (formerly East Texas State University) in 1975 and a degree in Business & Economic Development from the Little Rock in 2004.

University of Arkansas-Little Rock in 2004.

Slaughter became a member of the Arkansas Officials Association in 1975. He worked four state championship games and two All-Star games. He has been a speaker at numerous rules clinics.

From 1984-1989 Slaughter worked in the Southland Conference and the Arkansas Intercollegiate Conference. He worked three Division 1AA and NAIA playoffs. From 1989-1996 he worked in the Southwest Conference and Big 12. He was selected to work six major bowls – the Rose, Sugar, Gator, Holiday, Citrus and Fiesta. That included the 1993 National Championship game between undefeated and top-ranked Miami against undefeated and second-ranked Alabama.

From 1995 through 1997 Slaughter worked the World League – National Football League Europe, and was a part of the crew for the 1995 NFL Europe World Championship game between Amsterdam and Frankfort.



Perry Webb

Webb has spent his entire life in the state of Arkansas. The son of a Baptist minister, he has lived in virtually every corner of his native state.

He graduated from Walnut Ridge High School and received his associate degree from Williams Baptist College in 1977. He majored in business administration at Arkansas State University and was selected Alumnus of the Year by Williams

Baptist in 1996.

After almost five years in law enforcement where he served as a deputy sheriff of Lawrence County, Webb embraced a career change that would change his life. Serving as president of Chambers of Commerce from one corner of Arkansas to the other

is currently a teacher for the Fayetteville Public School District and is a member of the Arkansas Juvenile Detention Association.

New's high school officiating career started when he joined the Arkansas Officials Association in 1979. He later worked in the Arkansas Intercollegiate Conference from 1982-1986. From 1987-1991 he worked in the Southland and Midwestern Independent Conferences.

New is currently working in the Southeastern Conference, a move he made in 1992.

Mike New is married to Jackie Jones New. They are members of the Fellowship Bible Church of Lowell.

Slaughter became a National Football League official in 1996 and is currently still on the job. In 2005 he worked Super Bowl XXXIX between New England and Philadelphia. In 2003 and 2004 he worked the National Football Conference Championship games. He worked the 2001 Pro Bowl and has worked numerous playoffs.

Slaughter is currently employed by Arkansas Workforce of West Memphis as Business Services Manager, a position held since 2003. He previously worked for Munro & Company of Wynne as Operations and Engineering Manager.

Despite a hectic schedule during the fall, Slaughter remains committed to his community by working on the board of the Cross County Boys and Girls Club, as chairman of the WIB of Eastern Arkansas, as president of the Wynne Athletic Booster Club, as chairman of the Private Industry Council, as director of the Wynne Economic Development, as president of the Wynne Chamber of Commerce, as president of the Kiwanis Club, as a Sunday School teacher for 12 years, as a board member of the Mid-South Training Council, as vice chairman of the WAGE Advisory Committee and by working with Fellowship of Christian Athletes.

Slaughter is married to the former Marla Bradford of Lepanto. They have four children – Brent, Katie, Tab and Rhett and three grandchildren.

Slaughter's hobbies are outdoor sports, reading, public speaking, coin collecting and landscaping.

for the last 19-plus years, he has learned the ways of business and civic involvement.

As the executive director of the Walnut Ridge and Forrest City Chambers of Commerce and in his current position as president and chief executive officer of the Springdale Chamber, Webb has worked all facets of the business sector. From tourism, community and economic development to advertising, marketing and festivals, he has done it all. Managing staffs ranging in size from two to 10 and budgets as large as \$1.6 million, he has proven time and again he knows what it takes to get the job done right.

As an avocation, even with his heavy workload, Webb found time to serve as a high school basketball and football official for more than 25 years. During that time, he officiated more than

2,000 basketball games and over 400 football games, and worked nine basketball state tournaments; working the finals seven times. He was recognized as the 2000 National High School Federation Basketball Official for Arkansas.

Starting in 1987, he worked NCAA Division I basketball – working more than 250 games at the sport's highest amateur level. Although retired from officiating in 2001, he's still involved in support and education of the officiating profession. He served until this season as an evaluator of officials for the Southeastern Conference – the country's most prominent basketball conference, and still assigns officials for Arkansas's 7A-West Conference.

Perry and his wife, Rebecca, reside in Springdale. They have three children – Amanda and Sarah, both students at the University of Arkansas, and Bartley, who just graduated from Springdale High School and is attending the University of Notre Dame.

2006 Volleyball Rules Changes

2-1-4 Note: Clarifies the centerline court marking may be a shadow line which designates the required 2 inch centerline. Rationale: The rule requires a centerline which extends from sideline to sideline. The new addition to the rule, provides for flexibility when schools are re-lining the gymnasium floor. This notation allows a shadow line to designate the required 2-inch width by use of borders or outlines at least a ¼ inch wide, which shall lie within the 2-inch width.

2-2-2: Cables used to retract a ceiling-suspended net system and located only on one side of the net are playable overhead obstructions. Rationale: When a cable system is used to retract a ceiling suspended net system and cables are only on one side of the net and serve only to retract the net system this retracting cable is a playable overhead obstruction only on the side of the court where the cables are located.

4-2-3f: The placement of numbers on the center front of the uniform top may now be located no more than 5 inches below the bottom edge of any neckline, ribbing, placket or seam. Rationale: It was found that numbers being anywhere from three to five inches below the neckline when centered were clear and visible. More flexibility in this area will allow visible numbers to be legal which previously may not have been legal. This change does not make any existing legal uniform illegal and does not change the requirement if the number is on the upper left/right of the uniform top. Some uniforms previously illegal may now become legal.

10-4-1,2,3,4,5 New: Clarifies and defines when, how and where a libero replacement takes place, when the replacement is illegal, redesignation of the libero, proper procedures for handling exceptional substitutions and disqualifications involving the libero. Rationale: The position of the libero is now a part of the competition rules.

5-4-1d: Specifies the umpire shall verify the line-up has been entered correctly on the scoresheet by the official scorer. Rationale: Previously, errors have been made transposing the lineup from the coach's lineup sheet to the official scoresheet. Verification of the transfer of the lineup to the scoresheet by the umpire prior to the match will eliminate these mistakes.

5-6-1, 2 & 3: Officially adds the position of the assistant scorer (libero tracker) due to addition of libero play. Responsibility is to record libero replacements. Location at score table is next to official scorer. Rationale: The assistant scorer shall report to the referee 20 minutes prior to the match, be seated at the officials table next to the scorer and assist the officialing team with all libero tracking duties. Although a separate position is preferred, it is acceptable for the official timer to serve as assistant scorer.

6-3-2, 4-2-1 & 2, 5-1-1;5-5-2, 6-3-3a, 9-9-1: The rules relating to the libero have been changed to place the items in more appropriate sections of the rules. Further clarification has been included in the rules to

incorporate uniform numbering location of libero at moment of serve; game administration and penalties involving unnecessary delay. Rationale: Previously all rules relating to the libero were contained in Rule 6-3, Player Positions. Many of the items in the rule were not related to player position. Rules relating to the libero have now been placed within more appropriate locations in the rules which address specific play, uniforms etc.

7-1-1b: The designated libero for the match shall be identified on the team roster. The libero may be listed with two uniform numbers with the first as the non-libero number and the second as the libero number (i.e. 15/L4). "The libero number may not be a duplicate of any other player on the roster." Rationale: The libero must be designated for match play. This is done by listing an "L" before the uniform number of the libero. To assist schools in the supplying of a libero uniform numbers appear on the roster.

9-5-1c; 9-5-5: Definition of a block is changed to having a player close to the net who is reaching higher than the net and deflects the ball coming from an opponent. "Block attempt," "completed block," and "collective block" are defined. Back-row players may not complete a block or collective block. Rationale: The previous definition of a block created play situations in which officials were judging intent. In some situations the action of a back-row player who was no where near the top of the net was considered to be attempting a block and this action play was illegal. Current coaching strategy does not have back-row players not capable of blocking attempting the block and taking them out of play. Further, such action would not affect play with no contact with the ball. "Completed and collective" blocks and "block attempt" are now defined. Judging intent is removed in the new definition.

9-5-6: Specifies during play those player actions which are not legal for the libero. This placement puts libero player action with other player actions in Rule 9. Rationale: All player action, including libero, will be more easily located by officials and coaches in Rule 9.

12-2-6: Allows the head coach to stand in the libero replacement zone during any dead ball to instruct his/her players. The privilege is lost and the head coach must remain seated as outlined in 12-2-5 if a card is issued to anyone on the team bench. Rationale: Rules 9 and 12 require the coach to remain seated during a game except for a few situations (listed in 12-2-5). 12-2-6 now allows the head coach to stand during any dead ball to instruct his/her players. Once the referee extends the arm in preparation to beckon for serve, the coach must be seated. If the head coach or any other coach/team personnel receives a card, the head coach will lose the privilege to stand.

2006 Football Rules Changes

1-2-3g: Advertising and/or commercial markings may be permitted in the end zones.

1-3-5b: The official line-to-gain and down indicators shall be operated approximately 6 feet outside the sideline, where facilities permit.

1-5-1: Beginning in 2010, the visiting team shall wear white jerseys. Also, the home team has additional limitations as to how much white may be on its jerseys.

1-5-1a: At least a four-snap chin strap shall be required to secure the helmet.

1-5-1i: Mouth guards shall be of any readily visible color, other than white or clear.

1-5-1f2: Beginning in 2008, when measuring the length of a nonremovable cleat, the measurement shall be from the tip of the cleat to the sole of the shoe.

1-6-2: Phones and headsets are permitted for use by anyone during a authorized sideline time-out.

2-6-2a: An authorized sideline time-out shall be held directly in front of the team box and within the 9-yard mark.

2-29, 3-7-6, 9-6-4a: The language and definition of participation and substitution have been revised.

2-31-8: A definition has been added to define when a runner becomes a kicker.

2-40: The word "intentional" has been removed from the spearing rule.

4-2-2: A holder may now recover a snap and retain the same options of going back to a knee for the kick, advance, pass or running the ball.

7-2-8: The option to use a "planned loose ball" has been removed.

7-5-10, 13: The act of illegally touching the ball by an ineligible player carries the same penalty whether the act occurs behind, in or beyond the line of scrimmage.

Six-, Eight-, and Nine-Player: The 9-yard mark required in 11 player has been modified to 7-yard mark.
