

**6th Annual Liberty Medals® OFFICIAL RULES**  
**NO PURCHASE NECESSARY TO SUBMIT A NOMINATION.**

**Eligibility.** Nominees and persons submitting a nomination (“Nominators”) must be legal residents of NY, NJ, AND CT, 18 or older at the time of entry. All nominees must be living as of the date the nomination is submitted and the date on which they are required to sign an Affidavit of Eligibility and Publicity/Liability Release, as discussed below. Employees (and their immediate family members) of NYP Holdings, Inc, d/b/a the New York Post (“Sponsor”) and its agents are not eligible to be nominators or nominees.

**How to enter.** No purchase necessary. The Contest begins at 12:01 AM Eastern Time (“E.T.”) on 7/23/07 and ends at 5:00 PM E.T. on 9/13/07. Mail-in entries must be postmarked by 9/13/07 and received by 1:00 PM E.T. on 9/17/07. Online and facsimile entries must be received by 5:00 PM E.T. on 9/13/07. **Mail and Facsimile.** To enter, (1) fully complete an entry form available in select issues of the *New York Post* or, to enter without purchasing a newspaper, on a plain piece of paper no larger than 8 1/2” x 11”, hand-print your complete name, date of birth, mailing address, day and nighttime telephone numbers (including area codes), and your nominee’s name; (2) on one or more plain pieces of paper no larger than 8 1/2” x 11”, hand-print or type an essay (no longer than one hundred (100) words) about an outstanding New Yorker whom you feel deserves to be recognized. **You must identify the category in which he or she is being nominated;** and (3) either (i) mail these materials via first-class U.S. Mail only to “6th Annual Liberty Medals®”, P.O. Box 1013, New York, NY 10108, or (ii) fax these materials to 212-997-9272. **Online.** Or, to enter online, visit [www.nypost.com](http://www.nypost.com) and provide all of the information listed above and as requested at the web site (including essay and category). Nominators may nominate more than one person, but each nomination must be submitted separately with a separate essay. Nominator must obtain the consent of the nominee (and the consent of the parent/legal guardian of nominee if nominee is under 18) to his/her nomination prior to submission of entry materials. No reciprocations of nominations is allowed (e.g., a person is nominated by someone cannot, in turn, nominate that person and Sponsor reserves the right to disqualify such nominations. Incomplete forms/entries will be disqualified.

**Selection of Winners.** Nominations will be judged by a panel of judges chosen by Sponsor, which will include representatives from Sponsor. Judges’ and Sponsor’s decisions on all contest matters, including interpretation of contest rules, are final. Ten (10) winning nominees (one for each of the ten listed categories) will be determined on or about 9/19/07 (and will be notified soon thereafter) based on the unique and/or creative contributions or actions that nominee has performed which distinguish him/her. Sponsor reserves the right to require substantiation of the claims contained in any nomination, and to disqualify a nominee/nomination if such claims cannot be substantiated. Selected winning nominees (and their nominators) will be required to sign an Affidavit of Eligibility and Publicity/Liability Release as directed by Sponsor, or be disqualified. If a selected winning nominee is a minor under applicable law, his/her parent must also sign the Affidavit of Eligibility and Publicity/Liability Release. Winners must be available to

attend all functions that center around or on the date of the Liberty Medals event on October 17, 2007.
