TIE BREAK: The tie break systems for this tournament are 1.Sonnebonn Berger (sb) 2. Buchholz (wp)3. Tournament Performance Rating (TPR).

If the scores are level after the regular games for 1st position, tiebreak playoff system shall be used to break the tie.

Dates for the tie-break matches shall be set by the executive committee of BCF Inc. with the Chief Arbiter and the Players.

If the tie break involves two players then the following time controls shall be used.

After a new drawing of lots for colours, two tie-break games shall be played. The games shall be played using the DGT clock starting with 25 minutes on the clock and the addition of 10 seconds after each move.



TIE BREAK: (contd..)

If this tie-break match is again drawn, then, after a new drawing of lots, two tie-break games shall be played. The games shall be played using the DGT clock starting with 15 minutes on the clock and the addition of 10 seconds after each move.

If this tie-break match/round robin is again drawn, then, after a new drawing of lots, single sudden death games shall be played. The first player to win shall be declared National Champion. The sudden death games shall be played using the DGT clock with White having 4 minutes on the clock and Black five minutes and the addition of 10 seconds after each move.

If the tie break involves more than two players, then the BCF INC. executive committee, after consultation with the Chief Arbiter and the Players involved, shall decide on whether the play-off will be a round robin or knock-out using the above time controls.

APPEALS COMMITTEE:

The BCF INC. executive committe's nominee shall be Chairman of the Appeals Committee. There shall be two other members all of whom shall not be participants in the tournament. No member of the Appeals Committee shall sit in judgement in a dispute involving a player to whom he may be related.

All protests must be submitted in writing to the Chairman of the Appeals Committee not more than twenty four hours after the relevant playing session, or the particular infringement complained against. The Committee may decide on the following matters:

- a) a protest against a decision by an arbiter,
- b) a protest against a player's behaviour,
- c) a complaint alleging false interpretation of the regulations,
- d) a request for the interpretation of specific regulations,
- e) a protest or complaint against any participant, or



APPEALS COMMITTEE: (contd..)

If possible, the Committee shall reach a decision not more than three days after the submission of a protest. The appeals process shall include written representations and a written decision.

Every protest must be accompanied by a deposit fee of BDS\$ 50 (fifty Barbados Dollars). If the protest is accepted, the fee shall be returned. If the protest is rejected, the fee may be forfeited to the BCF Inc..

The decision of the Appeals Committee arising from any dispute in respect of these regulations shall be final.

Rescheduling:

The sudden death games shall be played using the DGT clock with White having 4 minutes on the clock and Black five minutes and the addition of 10 seconds after each move.

If the tie break involves more than two players, then the BCF INC. executive committee, after consultation with the Chief Arbiter and the Players involved, shall decide on whether the play-off will be a round robin or knock-out using the above time controls.

APPEALS COMMITTEE:
