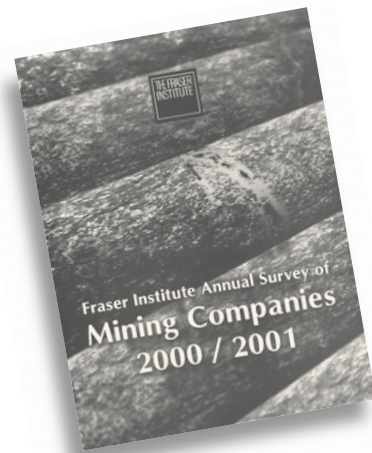


THE FRASER INSTITUTE ANNUAL SURVEY OF MINING COMPANIES 2000/2001

Mining exploration investment is a key indicator of the future health of the mining industry. While decisions to invest in exploration depend on a number of variables beyond a policy maker's control (such as mineral commodities prices and a region's mineral potential), these decisions are also highly sensitive to a region's policy climate. When companies decide to invest, they consider tax rates, regulations, access to land, and security of mineral tenure. While many provinces have favourable geology, unfavourable public policies are increasingly threatening new exploration.

In order to assess how various public policy factors affect a company's decision to invest in exploration, The Fraser Institute conducts a yearly survey of senior and junior mining companies operating in Canada, the US, and other international jurisdictions. This survey provides the public and policy makers with valuable information about the factors that influence new exploration and investment decisions that, in turn, affect the future health of the mining industry.

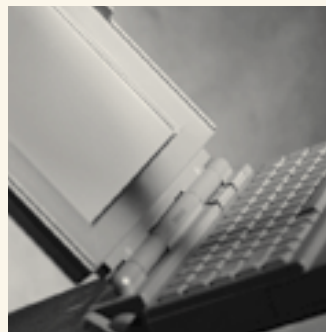

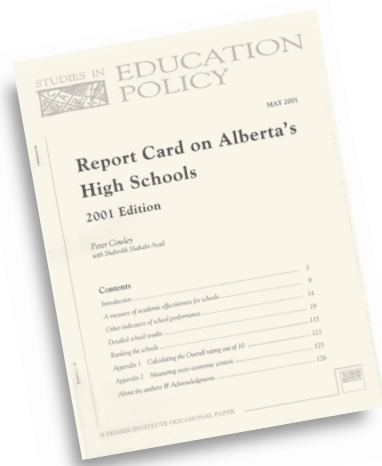
